Deposits and Payments: \$100.00 for each month booked / \$50 per week booked if weekly. All by US Funds Personal Check, Money Order or Cash. No Credit or Debit cards. Balance due upon check-in on the arrival date. Refund with written notice 45 days prior to originally scheduled arrival minus a \$50 cancellation fee, none thereafter. Email is an approved way of sending this notice. No refunds are given if departing before scheduled departure date. **Desert Gardens is a cooperative. If a long-term lease is issued and the new member desires immediate occupancy during your stay, you WILL be required to move to another assigned site. Management reserves the right to evict or refuse entry to any person who has evidenced a disregard for the rules. Guests and their visitors use the resort at their own risk. This property is privately owned.
